**WAIVER (A)
RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**

IN CONSIDERATION OF BEING PERMITTED TO PARTICIPATE IN THE SPORT OF OFF-ROAD RIDING OR BEING PERMITTED TO RIDE, OBSERVE, WORK FOR, OR FOR ANY PURPOSE PARTICIPATE IN ANY WAY IN THE SPORT, EACH OF THE UNDERSIGNED, FOR HIMSELF, HIS PERSONAL REPRESENTATIVES, HEIRS, AND NEXT OF KIN, ACKNOWLEDGES, AGREES, AND REPRESENTS THAT HE HAS, OR WILL IMMEDIATELY UPON ENTERING THE PROPERTY, AND WILL CONTINUOUSLY THEREAFTER, INSPECT SUCH PROPERTY AND ALL PORTIONS THEREOF WHICH HE ENTERS AND WITH WHICH HE COMES IN CONTACT, AND HE DOSE FURTHER WARRANT THAT HIS ENTRY INTO THE PROPERTY OR AREAS AND HIS PARTICIPATION, IF ANY, IN THE EVENT CONSTITUTES AN ACKNOWLEDGEMENT THAT HE HAS INSPECTED SUCH PROPERTY AND THAT HE FINDS AND ACCEPTS THE SAME AS BEING SAFE AND REASONABLE SUITED FOR THE PURPOSE OF HIS USE, AND HE FURTHER AGREES AND WARRANTS THAT IF, AT ANY TIME, HE IS IN OR ABOUT THE PROPERTY AND HE FEELS ANYTHING TO BE UNSAFE, HE WILL IMMEDIATELY ADVISE THE OFFICIALS OF SUCH AND WILL LEAVE THE PROPERTY. 1. HEREBY RELEASES, WAIVES, DISCHARGES, AND COVENANTS NOT TO SUE THE MERIDIAN MOTORCYCLE ASSOCIATION, THE CITY OF MERIDIAN (PROPERTY OWNERS), CLUB MEMBERS, OWNERS, AND LESSEES OF PREMISES USED TO CONDUCT THE SPORT OF OFF-ROAD RIDING AND EACH OF THEM, THEIR OFFICERS, AND EMPLOYEES, ALL FOR THE PURPOSES HEREIN REFERRED TO AS "RELEASES," FROM ALL LIABILITY TO THE UNDERSIGNED, HIS PERSONAL REPRESENTATIVES, ASSIGNS, HEIRS, AND NEXT OF KIN FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREOF ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE WHILE THE UNDERSIGNED IS ON THE PROPERTY, AND/OR RIDING, OFFICIATING IN, OBSERVING, WORKING FOR, OR ANY PURPOSE PARTICIPATING IN THE SPORT; 2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS THE RELEASEES AND EACH OF THEM FROM ANY LOSS, LIABILITY, DAMAGE, OR COST THEY MAY INCUR DUE TO THE PRESENCE OF THE UNDERSIGNED IN OR UPON THE PROPERTY OR IN ANY WAY RIDING, OFFICIATING, OBSERVING, OR WORKING FOR, OR FOR ANY PURPOSE PARTICIPATING IN THE EVENT AND WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASES OR OTHERWISE. 3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE DUE TO THE NEGLIGENCE OF RELEASEES OR OTHERWISE WHILE IN OR UPON THE PROPERTY AND/OR WHILE RIDING, OFFICIATING, OBSERVING, OR WORKING FOR OR FOR ANY PURPOSE PARTICIPATING IN THE EVENT EACH OF THE UNDERSIGNED EXPRESSLY ACKNOWLEDGES AND AGRESS THAT THE ACTIVITIES OF THE EVENT ARE VERY DANGEROUS AND INVOLVE THE RISK OF SERIOUS INJURY AND/OR DEATH AND/OR PROPERTY DAMAGE. EACH OF THE UNDERSIGNED FURTHER EXPRESSLY AGREES THAT THE FORGOING RELEASE, WAIVER, AND INDEMNITY AGREEMENT IS INTENDED TO BE AS BROAD AND INCLUSIVE AS IS PERMITTED BY THE LAW OF THE PROVINCE OR STATE IN WHICH THE SPORT IS CONDUCTED AND THAT OF ANY PORTION THEROF IS HELD INVALID, IT IS AGREED THAT THE BALANCE SHALL, NOTWITHSTANDING, CONTINUE IN FULL LEGAL FORCE AND EFFECT. THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, AND FURTHER AGREES THAT NO ORAL REPRESENTATIONS, STATEMENT OR INDUCEMENTS APART FROM THE FOREGOING WRITTEN AGREEMENT HAVE BEEN MADE.
